TERMS AND CONDITIONS

All parties must be pre-booked and a completed Children's Party Booking Form signed and returned 5 (Five) days before the event, (unless agreed prior). Bookings are subject to availability and will be confirmed via email once availability has been checked. Parties will be held within the "Party Zone" (a segregated area in the Bar & Grill separated by room dividers) and will run on the hour and sessions last 50 minutes at a cost of £10 per child. Included in the price is food, squash/water, plates, napkins and cups. Food will be placed on the table within the relevant "Party Zone" at the designated time. We will not be held responsible for food getting cold due to late arrival of children so please ensure that they are within the "Party Zone" on the hour booked. Charges are based on a minimum of 10 (Ten) full paying children and payment must be made via BACS (details as above on booking form) or via Card or Cash 48 hours prior to the booked party. If the money is not received into our account by closing time 48 hours before your party, the party will be cancelled immediately, (unless agreed prior). In the event of children not attending for any reason on the day no refund will be given. All children's party food must be pre-ordered from the Kids Menu only. Menu will be forwarded via email or given in person prior to the event. We cannot guarantee that any food may contain allergenic products, but if a child at the party has any medical/allergy requirements this information MUST be entered on the form and any medication must be carried by the relevant child/party organizer. The child must also be identified to a staff manager prior to the party commencing. The party organizer will be responsible for the birthday cake and its ingredients brought to the party (with prior agreement). In providing a cake you will be responsible for the candles (as these are not provided by ourselves) but when using a flame to light please ensure that fire safety is paramount to everyone. If parents/guardian of any child at a party are not present the party organizer will be solely responsible for each child during the duration of the party. We would ask that whilst the children enjoy their time with us we do not allow shouting, throwing food or drink, or causing any disruption of any kind within their party area or within the Bar & Grill at any time, (as other customers will be dining at the same time so noise to be kept to a minimum). Damage to any items in the Bar & Grill by any party members (including adults) will be chargeable to the party organizer. As parent/guardian we hold you responsible for any event that may arise and become a risk to the Park staff, any of the children attending or to other visitors to the Park, and we reserve the right to stop the party if we feel the need and no refund will be given. It is the organisers responsibility to ensure that birthday presents and valuables are safe at all times as Lagoon Park will not be held responsible for any missing items. Please note that we do not allow wet clothes in the Bar & Grill at any time so please ensure that all children are dressed in dry clothes for the party.
