*I have read and agree to be bound by Lagoona Park, it's Directors, Employees and Members etc from any claim arising from any incident or accident whatsoever or howsoever caused. I confirm that I have read and understand the rules of the lake & safety notices located around the site. I confirm my insurance is valid and will be updated when expired. I confirm that all persons riding my personal watercraft are covered on my insurance and I have given them full instruction and safety briefing on machine use, course layout & direction, allowing enough space between them and other skiers when overtaking (no undertaking) and being aware of the danger with persons in the water due to capsizing. I have provided instruction on kill cord/lanyard use and maintaining a slow speed whilst approaching the banks of the lake. I also confirm that my guests have read the rules of the lake and safety signs located on site and understand them. I confirm that any minors riding alone are named on my insurance and have undertaken the RYA PWC Proficiency Course and that the minimum age limit for Stand Up Jet Ski's is 14 years and Sit Down Jet Bikes is 16 years whilst using a personal watercraft alone at Lagoona Park. I confirm that no food will be brought on site by myself or my guests. All dogs must be on a lead + any mess must be cleared and placed in waste bins provided on site. Buoyancy Aids MUST BE WORN AT ALL TIMES whilst on the water. I understand that the launching fee is payable for the day (irrespective of arrival time). I am aware that I must vacate the lake by 6.30pm as the site closes at 7pm. Lagoona Park is closed from November – End March annually. I know that Lagoona Park is closed every Tuesday and am required to call or check the website/social media before coming during weekdays as the lake may be booked for a private event, whereby access will be refused. I understand that Lagoona Park provides a launching service via the onsite vehicle for stored personal watercraft, by giving verbal permission to use the launching vehicle I understand it leaves Lagoona Park with no responsibility for any damage caused to my personal watercraft or trailer while using this service.
